CIDB REGISTER OF CONTRACTORS TO REFLECT B-BBEE CHARTER RATINGS

The Minister of Trade and Industry has published the Construction Sector Charter, as a sector code on black economic empowerment in terms of section 9(1) of the BBEE Act, 53 of 2003 in Government Gazette number 32305 published on 5 June 2009. The Minister of Finance has published the draft Preferential Procurement Regulations, 2009 aligned with the prescripts of the BBEE Act, 53 of and its related strategy on 14 August 2009.

The cidb has commenced the process of reflecting B-BBEE Charter ratings on the cidb Register of Contractors. Please note that this is an optional requirement at this stage and your registration with the cidb will not be affected in any way. You are invited to have your B-BBEE Charter rating reflected on the cidb Register of Contractors if you are in possession of a B-BBEE certificate or Letter of Exemption. B-BBEE Certificates are issued by ratings agencies accredited by the South African National Accreditation System (SANAS). Enterprises that have an annual turnover of less than R 5million, may submit a Letter of Exemption from an auditor / accounting officer.

The B-BBEE Certificate or B-BBEE Letter of Exemption is valid for a period of 1 year. The B-BBEE rating will automatically be removed from the cidb Register of Contractors when it has expired without affecting your grade/s with the cidb. It is your responsibility to update your B-BBEE status with the cidb upon expiry.
